\_\_\_\_\_ I choose to work towards fundraising \$400.00 of profit to the school and volunteer at least twenty (20) service hours. The first \$200.00 and 10 service hours are due by Dec. 9, 2011. All service hours not completed by Dec. 9 will be added to my account at the rate of \$10.00 an hour. The second \$200.00 of the required fundraising fee is due by April 9, 2012. All service hours not completed by April 30 will be added to my account at the rate of \$10.00 an hour.

\_\_\_\_\_ I choose to pay \$550.00 and not volunteer twenty (20) service hours. The full amount is due at the time of registration.

\_\_\_\_\_ I choose to work towards fundraising \$575.00 of profit to the school because my child is receiving financial assistance. As prescribed in the Diocesan Tuition Grant Application, I will volunteer twenty (25) hours of service to Bishop Garriga Middle Preparatory School. The first \$287.50 and thirteen service hours are due by Dec. 09, 2011. All service hours not completed by Dec. 9 will be added to my account at the rate of \$10.00 an hour. The second \$287.50 and twelve service hours are due by April 9, 2012. All service hours not completed by April 30 will be added to my account at a rate of \$10.00 an hour.

I understand that if I choose to assist in fundraising, there are only five (5) mandatory fundraisers that will count toward my fundraising commitment. Half of the total sales of each of these fundraisers will be deducted from my mandatory total. Any additional fundraisers or functions are strictly voluntary and will not count toward my fundraising commitment.
